Rules for the admission in Shastri (B.A.) and Acharya (M.A.)

1. The student can enrol himself only for the syllabi/curriculum/course taught by colleges/Mahavidyala/departments for which they have got the approval from the university.
2. The student who has got the admission in any degree course will have to fill the enrolment form at the time of admission in the first year.
3. During the second and the third year of the degree course and the second year of the post graduate course, no enrolment form is to be filled up.
4. Once the student is enrolled in any course, he or she cannot be enrolled for the same course again without cancelling the previous enrolment. The results of the exams under the previous enrolment will be considered as cancelled. The student will have to apply for the cancellation of the old enrolment, or he will not get the new enrolment.
5. After enrolment of the student if the student fails the examination, he needs not to fill the enrolment form again but he will have to appear in the exams as the repeater and apply for the same.
6. Eligibility:
 - 6.1 To get admission in the first year of Shastri, the student must have passed H.S.C. or the exams equivalent to it.
 - 6.1.1. The student who has passed H.S.C. with stream like arts, commerce, science or any other stream except Madhyama is eligible to get admission in the first year of Shastri. But the Mahavidyalay/college will have to hold the bridge exams (setu pariksha) for Sanskrit for the admission seekers and send the certificates to the University.
 - 6.1.2 According to the university circular, the student who passed H.S.C. with Vedbhushan (with current subjects), or the exams held by Mukta Vidyalaya Shiksha Sansthan, Lucknow (state), State Madresa Shiksha Board-Lucknow, Jamiya Urdu-Aligarh, Mukta Vidyalay Shiksha Sansthan-Lucknow (center), National Institute of Open Schooling- Delhi will be eligible for the admission in the first year of Shastri.
 - 6.1.3. The student who passed H.S.C. from any other board outside Gujarat but recognized by the state government is eligible to get enrolled in the first year of Shastri.

7.3 The important suggestions to the candidates regarding the selection of the subjects.

7.3.1 The student has to appear in the exams of the selected subjects in both the semesters. The subjects mentioned in the enrolment are to be mentioned in the exams form.

7.3.2 In Shastri programme paper no. 5 & 6 in each semester are of the main subjects (CC) and in Acharya programme paper no. 2,3, & 4 in each semester are of the main subjects(CC).

7.3.3 The student is not allowed to change the main subjects once mentioned in the enrolment form. This is applicable for both the programmes, Shastri and Acharya.

7.3.4. The subordinate subjects (CE/GE/GF) (other than the main subjects) can be changed in the semester 3 and 5 in the programme and one has to inform the university at the time of submission of the enrolment form or at the time of getting admission in written.

7.3.5. The subjects selected as the main subjects cannot be selected as the subordinate subjects in any programs.

7.3.6. The subject of Environment is compulsory for the students of the semester 2 of the first year. It is compulsory for the student to pass this subject with minimum 40 % marks in theory and internal. The marks will not be counted in the total marks mentioned in the mark-sheet. It will not be included while determining the grade.

8. Enrolment Fees:

8.1 The enrolment fees for the Shastri and Acharya program is Rs.100.

8.2 The college is to give receipt of the enrolment fees to the students.

8.3 The college has to deposit the enrolment fees to the university through net banking portal of AXIS BANK. The manual for the online transaction is given on the website of the university. After depositing the fees the reference copy is to be submitted along with the forms.

8.4 Enrolment fees is non-refundable.

9. In-Take

Date :

9.1 The college or institute is allowed to admit 75 students in Shastri program and 40 students in Acharya program. To enrol more students the college needs to get approval from the university to increase the number of the class. Only after the consent, more students can be enrolled.

9.2 If the number of admission application is more than the in-take capacity, the merit list has to be prepared by the college. And the admissions have to be given accordingly.

9.3 College has to maintain the reservation ratio as per the government rules.

10. **Age:** There is no maximum age limit for the programs, Shastri and Acharya

11. The time limit for the completion of the study.

11.1 The time limit to complete the study for the degree of Shastri is five years. The curriculum is for three years and the students are given additional two years to pass the papers which they failed in regular course.

11.2 The time limit to complete the study for the degree of Acharya is four years. The curriculum is for two years and the students are given additional two years to pass the papers which they failed in regular course.

11.3 If any student completes the time limit for a particular course and could not pass any exam of that course, he or she will have to re-register himself or herself.

12. Passing Standard

12.1 The students need to get 40 % marks in each head for the each question paper in every semester.

12.2 The student needs to get minimum 28 marks out of 70 in the external exams held by the Mahavidyalaya/college and minimum 12 marks out of 30 in the internal exams held by the college.

12.3 The internal 30 marks is bifurcated as 10 marks for assignments, 10 marks for presence in the class and 10 marks for overall discipline of the students. The college or institute is ordered to preserve the records related to the internal marks of the student until the student gets the degree from the university. The college has to provide the university with these records when asked.

12.4 The student will not be eligible if his classroom presence is less than 70%. The principal has to endorse about the required presence. If the presence of any student is not 70% or more, his application for the appearance in the exams will be considered invalid.

13. Medium

Date :

The language of answer in the semester 1 will be Sanskrit with other languages like Hindi and Gujarati in Shastri Program.

From semester 2 to 6 in Shastri program and semester 1 to 4 in Acharya program the medium for answers in exams will be Sanskrit. In modern subjects, the medium of answer will be Gujarati in Gujarati subject, Hindi in Hindi subject, English in English subject and Gujarati, Hindi and English for Computer subject. The medium of answer in Social Studies, Economics and Environment will be Gujarati/Hindi/Sanskrit. The medium for Ancient Economics and Political Science will be Gujarati/Hindi for the first semester, and for the remaining semester it is Sanskrit.

14. General rules

14.1 For those students who have been enrolled in other universities will have to submit the migration certificate within 45 days after they get admission. If they fail to do so, their admission will be cancelled and the result will be withheld.

14.2 Those who want to get provisional eligibility certificate for the admission will have to apply at the time of enrolment and pay the fees for it.

14.3 The enrolment forms are to be submitted to the university through the college/Mahavidyalaya.

14.4 If the fees are not paid, or the minimum eligibility is not fulfilled or the documents are not attached or the attached copies are not legible, or the important details in the forms are incomplete or not true, the application form will be cancelled.

14.5 After the students get enrolled, the university sends the list of the enrolled students to college/Mahavidyalaya. The students listed in this will be considered as the admitted. The enrolment is a unique ID of the students and hence it is used in all kinds of communication with the university and it is to be mentioned in the forms.

14.6 A student can get transfer into another college by the following procedure and rules.

14.6.1 The student seeking transfer must have passed all the exams held by the Mahavidyalaya/college where he studies so far by the time of the application for the transfer.

14.6.2. The student has to get a transfer certificate from the college in which he or she is studying at present, and submit it to the college he wants to join.

A college has to submit the transfer the application to the university before the last date of enrolment as per the guidelines provided by the university by its circular no. ssu/admission/circular-tr-13-tr-13/2731/17, dt. 05/08/2017. The student can be transferred after the consent from the university.

14.7 The reservation policy framed by the university /government is to be followed by the college in admission process.

14.7.1. The admissions are given following the reservation policy in effect at that time.

14.7.4 In case of admission based on merit list, the institute has to verify all the related documents by the university before declaring the merit list and the details regarding the rounds of admission is to be provided to the university.

14.8 It is the responsibility of the head of the Mahavidyalaya/college to verify the copies of marks-sheet attached by the students with the enrolment form with the original mark-sheet.

14.9 After the enrolment number is given to the student, the information provided by the students in the enrolment form cannot be changed. If the students wish to change the information, he or she will have to apply with the necessary documents. And the university can use the information in future if it is needed.

14.10 The name of the students in the university record will be as per the enrolment form. The modification or change in name can be done only if the students produce the government gazette. The affidavit or the marriage certificate will not be considered as valid evidence for the same.

14.11 The Mahavidyalaya/college will issue the identity cards to the students.

14.12 The student seeking admission/enrolment/registration in the Mahavidyalaya/college needs to attach the following documents with the enrolment form.

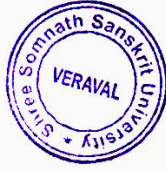
